2 ASSIGNMENT

 - 4.1.2 the Maturity Value is the latest maturity benefits supplied by the insurance company;
 - 4.1.3 the Price Discount Rate (PDR) is the rate at which the maturity value and the future payable premiums have been discounted to calculate the sale price;
 - 4.1.4 the values of the policy may go up or down depending on the insurance company's allocation of future bonuses;
 - 4.1.5 the Assignee has been given the opportunity to seek independent legal advice on the effect and implications of entering into this Assignment.

5.2.1 the Assignee's written permission has been obtained;

5.2.2 the disclosure is to obtain professional advice and/or is required in the course

of legal proceedings, or;

5.2.3 directed by any relevant authority and/or under compulsion of law.

6 GOVERNING LAW AND DISPUTE RESOLUTION

6.1 This Assignment is governed by Singaporean Laws. A person who is not a party to this

Assignment shall not have any rights under the Contracts (Rights of Third Parties) Act

(Cap. 53B) or otherwise, to enforce the terms herein.
